### Regional Stakeholder Engagement

- Two methods for potential consultation were discussed
  - o A potential NCPC stakeholder event could be held in a regional location in partnership with a local entity.
  - o An online consultation on the NCPC website.
- The following questions were asked of Council Members:
  - How can the Council better incorporate regional issues into our publications?
  - How can the Council improve its engagement with regional stakeholders? Should the Council organise events in different parts of the country to meet with these stakeholders?

Members comments:

- Members noted that there is a lack of data on regional issues in Ireland. Sourcing accurate data is resource and time heavy.
- Members agree that regional engagement is important, and it is vital that the NCPC represent all of Ireland.

## **European NPB Mandate**

- Section 3 of the 'NCPC Engagement' Discussion Paper highlights the evolution of the NCPC into Ireland's National Productivity Board and discusses the recent developments in the Network for the productivity boards.
- The objective of this agenda item is to discuss NCPC engagement and communications with other National Productivity Boards and to discuss how to further engage in this space.
- The following question was asked of Council Members:
  - How can the Council deepen our engagement with the European National Productivity Board Network?

# Members comments:

- Council members were supportive of further engagement with the NPB Network.
- One member proposed that the NCPC should focus on comparing Ireland to countries of similar size and attributes.
- One member noted that the NCPC should seek best practice on regional dimension from other NPBs.

IBEC note that they have done work in this area and would facilitate with data.



#### **NCPC Bulletins**

 The objective of this discussion is to inform the Council of the latest NCPC Bulletin and the coverage it received as well as discuss upcoming bulletins.

#### Members comments:

- Council members were supportive of a bulletin on inflation.
   Some noted that although inflation is a global issue, responses to it will diverge amongst different countries.
- One council member noted that an important role of the NCPC is to spell out the reality of inflation.
- The Chair thanked members for their comments and suggestions and noted that labour supply in particular is a whole of economy issue which would be one of the larger long-term impacts of COVID-19 related disruption.

# Section 1: Government Response (Chair)

 The objective of this discussion is to discuss how to best address the Government Response to Challenge 2021.

# **Issues for Discussion**

The Council's well-developed process for issuing targeted, actionable recommendations is a key strength of our existing annual report structure. Are there ways this process can be improved further? How best can the Council monitor progress on past recommendations to ensure tangible improvements are being made?

### Members comments:

 Council members were supportive of the Secretariat monitoring progress on Council recommendations in order to ensure the Council's advice gains traction within the policy system.

## Section 2: Topics for Inclusion in Challenge 2022 (Chair)

 The objective of this discussion is to gather Council Member views on Challenge topics.



## Inflation/ costs

- Members noted that inflation is a global external issue. It is important to focus on domestic cost pressures to avoid inflation issues worsening. The consensus was that we should focus on issues we can control.
- One member noted that a productivity lens should be placed over the whole document.
- Members noted that it will be difficult to balance the overheating domestic market vs international disruptions.
   Numerous inflationary pressures, some outside domestic policy levers control.

### Labour Market

- One member raised the topic of examining the positive impact on competitiveness and productivity of collective bargaining.
- Two members noted that addressing the labour market is crucial as staff shortages continue to be felt.
- One member brought up the National Training Fund Levy.
   Members agreed that it would be positive to examine the impact this funding can have on compound productivity.
- Another member stated that the 'Living wage' should be included in the document. Many other members agreed noting that Tánaiste will likely bring to Government after Easter.
